Notes - Restricted Funding

- 1. The forum received grants from North Lanarkshire Council which totalled £2,207, this was to contribute towards the cost of hall hire, promotion and hospitality and gala day costs. These grants were fully utilised.
- 2. The forum received a grant from Sanctuary Housing of £1,240 this was to contribute towards the gala day costs. This grant was fully utilised.
- 3. The forum received a grant totalling £1,000 from Scottish Water, this was to contribute towards gala costs for 2014. These grants have now been fully utilised.
- 4. All funds remaining are un-restricted.

4. Trustees' remuneration and expenses

No remuneration was paid or payable during the year to any of the charity trustees nor to any person connected to them. Volunteer expenses of £441.99 were reimbursed to trustees in the year for purchases or travel undertaken on behalf of the forum.

The members of the committee are required to act in accordance with the terms of the Forum's constitution. They are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the Forum. They are also responsible for safeguarding the assets of the Forum and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

INDEPENDENT EXAMINER'S REPORT TO THE MEMBERS OF THE COMMITTEE OF CUMBERNAULD COMMUNITY FORUM
